Update on Resignation of State Secretary

The State Committee of Management (SCM) convened a teleconference today to discuss the short and long term stability of the Union after the resignation of State Secretary Jamie Hawkins.

After lengthy discussion and advice from John Payne (Hall Payne Lawyers) it was determined:

- To appoint an interim/Acting State Secretary to carry out the role and function of the position.
- To seek further clarification of our rules so we can progress to an election/appointment as soon as possible

I now wish to advise Members that I have been appointed to this interim position and that my appointment will not exceed one month from today as determined by SCM. Any further determination of SCM will be advised via a "Code 2" as will any final clarification provided by the Union's Lawyers.
